Capital markets are markets for buying and selling equity and debt instruments. Capital markets channel savings and investment between suppliers of capital such as retail investors and institutional investors, and users of capital like businesses, government and individuals. Capital markets are vital to the functioning of an organizations capital requirements.

Capital markets help channelise surplus funds from savers to institutions which

then invest them into productive use. Generally, this market trades mostly in long-term securities.

Capital market consists of primary markets and secondary markets. Primary markets deal with trade of new issues of stocks and other securities, whereas secondary market deals with the exchange of existing or previously-issued securities. Another important division in the capital market is made on the basis of the nature of security traded, i.e. stock market and bond market.

Capital markets serve two purposes. Firstly, they bring together investors holding capital and companies seeking capital through equity and debt instruments.

Secondly, and almost more importantly, they provide a secondary market where holders of these securities can exchange them with one another at market prices.

Without the liquidity created by a secondary market, investors would be less inclined to purchase equity and debt instruments for fear of being unable to unload them in the future.
