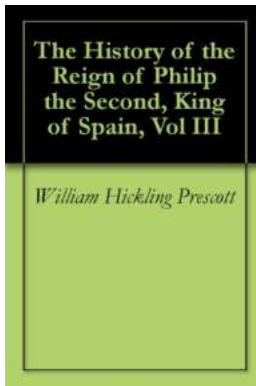
Fortunately while group efforts failed so many times in the past, today, on June 11, 2018, the station was purchased by the Ford Motor Company.

Congratulations Detroit!



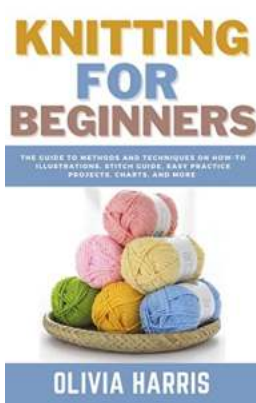
